AAK AT THE KENYA URBAN FORUM 2023

AAK attended and exhibited at the Kenya Urban Forum organized by the State Department of Housing and Urban Development from 14th-16th June 2023. Apart from exhibiting at the event, the AAK president presented on the critical gaps in the presentations made on Urban Housing by the National Housing Corporation and the national government. Some of the salient issues included: the need for having proper plans in place before planning and implementing the AHP, inadequate inclusion of the private sector, counties having a critical role in AHP and we do not have proper structures to manage the proposed housing fund.



PARTNERSHIPS

HABITAT FOR HUMANITY INTERNATIONAL (HFHI)

The housing impact assessment study established an understanding of how the housing concept was affected by COVID-19 within the Nairobi Metropolitan Region. On 29th June, AAK conducted a training based on the Healthy Homes Guidelines and Checklist, a framework. AAK developed the guidelines for use in building new healthy and safe homes, retrofitting existing ones, and as a guide to those renting homes. The training received 10 accreditation points from the National Construction Authority (NCA) and 2.5 points from the Board of Registration of Architects and Quantity Surveyors.





AAK MENTORSHIP AT KIST

On the sidelines of the Healthy Homes training, a team from AAK held a student mentorship talk with the Kiambu Institute of Science and Technology students and encouraged them to join AAK. We also received positive feedback from KIST and agreed on the need to partner to connect the students with the built environment professionals.

MULIKA MJENGO INITIATIVE

This project seeks to create a public policing platform that allows the members of the public to identify buildings and construction practices which do not adhere to the laid down standards.

A web page of the Mulika Mjengo Site has been added on the AAK website as well as on the BuildHub website. The project will be launched during the AAK Je, Una Mjengo? Campaign.


Access to information on development approval, either a building permit or planning approval, remains a significant challenge in the country. This is despite the reality that each County's Processes for obtaining the documents differ, and no County has documented its processes. The lack of clarity in the processes involved in the application for these documents makes the application for completing an application unpredictable, long, and tedious.

Following this, AAK commissioned research on the above processes in select counties in Kenya with the aim of providing the public with the information. As a result, AAK has now made it much easier for you to obtain a Building Permit or Planning Approval in Kenya by providing information on step-by-step procedures, the duration for approval, and fee charges for obtaining these approvals.

The portal is still being updated and we have data on 33 counties so far. We have also uploaded all the relevant legal and policy frameworks to the Hub, making it a one-stop shop for all the information you need in the approval processes. Find out more: https://buildhub.aak.or.ke/

AAK SURVEYS

THE NAIROBI PLANNING & DEVELOPMENT MANAGEMENT SYSTEM (NPDMS) USER EXPERIENCE 2023 SURVEY



The department conducted a comprehensive survey on the user experience of the Nairobi Planning & Development Management System (NPDMS). This initiative was prompted by numerous complaints received from our esteemed members regarding the system's functionality and efficiency. The findings revealed that members continue to experience a lot of challenges using the system.

Specifically, several experts mentioned difficulties and challenges during the migration from eDAMS, such as the need for human intervention, loss of previous applications, and longer processing times.

Other challenges experienced included delays in getting approvals, with some taking up to one year, 93.2% of the professionals end up making physical visits to the county, which defeats the essence of an online system, as well as the recurring concern over the inadequate communication channels.

Some of the recommendations members gave were the need to prioritize applications which are still stuck in the eDAMS system, the county should eliminate human interference in the system and take legal action against county officials who tamper with the system, the need for the county to regularly maintain the system to improve its efficiency and user-friendliness and the necessity of efficient communication channels.

The association attended the UN-Habitat assembly which was held in Nairobi, Kenya from 5 to 9 June 2023. The theme of the session is "A sustainable urban future through inclusive and effective multilateralism: achieving the Sustainable Development Goals in times of global crises."

AAK also participated in the side events, including the Roundtable hosted by the Commonwealth Africa Initiative on the themes of sustainability, construction and the future of the built environment in Kenya. During the period, AAK hosted the President of the Commonwealth Association of Architects, Peter Oborn, Vice President, CAA Senior Vice President Stephen Oundo, CAA Vice President Africa Wilson Mugambi, and the President of the Antigua and Barbuda Institute of Architects, Curisa Smith.

PRESS BRIEFING ON THE AFFORDABLE HOUSING CRISIS



AAK held a press briefing on the 9th June 2023 to give recommendations on the affordable housing crisis in Kenya. In the briefing, AAK emphasized that housing is not just about building the structure but about building sustainable communities. Additionally, the government needs to put in place proper structures to guide and manage the housing program effectively, including establishing the Kenya Housing Board.

This press briefing attracted attention in the public space and led to our engagement with the media including appearances on television - KTN TV Big Morning Show on Kenya Urban Forum Launch and Citizen TV DayBreak on Construction Costs.

AAK MEETING WITH THE WORLD BANK

AAK and World Bank held a subsequent meeting after the meeting with the National Council of Economic Affairs on 31st May to further discuss the challenges and recommendations that the World Bank could support in spearheading. The objective is to develop an action plan up to June 2024.


KOMAZA
