## **MULIKA MJENGO** INITIATIVE




The Mulika Mjengo project is an initiative by the Architectural Association of Kenya (AAK) aimed at empowering the public to identify and report unsafe construction sites.

These are some of the Elements to be highlighted:

#### **Active Construction Sites**

#### Site board information:

- · Name of area and land reference
- · Ownership details
- Project description
- · Supervising consultants with registration numbers



Statutory approval numbers

#### Safety signage throughout the site



#### Fall protection systems:

- Guardrails
- Safety nets
- Personal fall arrest systems



### • Proper zoning for residential, commercial, and industrial areas

- · Construction on well-drained land, avoiding marshy grounds
- No private development on public land or recreational spaces
- · Safe and easy access to buildings
- · Adequate parking provision
- No leaks, water damage, or signs of dampness
- Adequate permanent ventilation

### Personal Protective Equipment:

- Hard hats
- · Safety glasses
- Earplugs
- Gloves
- · Safety shoes or boots

### **Existing Buildings**

- Structural integrity:
  - No visible cracks, leaning walls, sagging beams, etc.
- Stable and well-maintained buildings
- Fire safety mechanisms such as smoke detectors, fire alarms, fire extinguishers and clear and unobstructed emergency exits
- Proper electrical wiring and management:
  - Safety features for people with disabilities
  - Measures to prevent the breeding and spread of disease-carrying vectors

## AAK AT THE INTERNATIONAL UNION OF ARCHITECTS (UIA) CONGRESS 2023



AAK exhibited and had a delegation at the UIA World Congress from 2nd to 6th July 2023. During the congress, AAK presented what we are doing to "Leave no one Behind".

These included the Inclusive and Integrated Infrastructure Framework for Kenya (3If), Grow A Classroom project to develop better learning environments for public schools, the Safari Green Building Index a homegrown rating tool for the tropical climate, the Je, Una Mjengo? campaign for professionalism in the built environment and Healthy Homes Guidelines for improving existing housing stock to be decent and safe spaces.

We received a lot of interest from various organizations whom we will engage on the next steps.

### NATIONAL SYMPOSIUM ON DESIGNING AND COSTING OF AFFORDABLE HOUSING PROJECTS



On 13th July 2023, AAK took part in the National Symposium on Designing and Costing of AHP. AAK President Arch. Florence Nyole moderated a key panel on during the session and some of the critical issues raised were the need to reduce over-designing, leveraging affordable building materials, and the need to introduce sustainable standards. The Quantity Surveyors Chapter was tasked with preparing small price guidelines that will be shared with the Ministry.

## MEETING WITH CECM BUILT ENVIRONMENT AND URBAN PLANNING, NAIROBI COUNTY



On 11th July, Architects met with the Nairobi County Executive Committee Member for Built Environment and Urban Planning, S. G. Mwangi, and the officers to discuss development control invoicing and payments processing challenges. From the meeting, it was agreed that AAK would compile the list of payments that are yet to reflect on the NPDMS portal.






## **AAK BUILDHUB**


Access to information on development approval, either a building permit or planning approval, remains a significant challenge in the country. This is despite the reality that each County's Processes for obtaining the documents differ, and no County has documented its processes. The lack of clarity in the processes involved in the application for these documents makes the application for completing an application unpredictable, long, and tedious.

Following this, AAK commissioned research on the above processes in select counties in Kenya with the aim of providing the public with the information. As a result, AAK has now made it much easier for you to obtain a Building Permit or Planning Approval in Kenya by providing information on step-by-step procedures, the duration for approval, and fee charges for obtaining these approvals.

The portal is still being updated and we have data on 33 counties so far. We have also uploaded all the relevant legal and policy frameworks to the Hub, making it a one-stop shop for all the information you need in the approval processes. Find out more: https://buildhub.aak.or.ke/
